

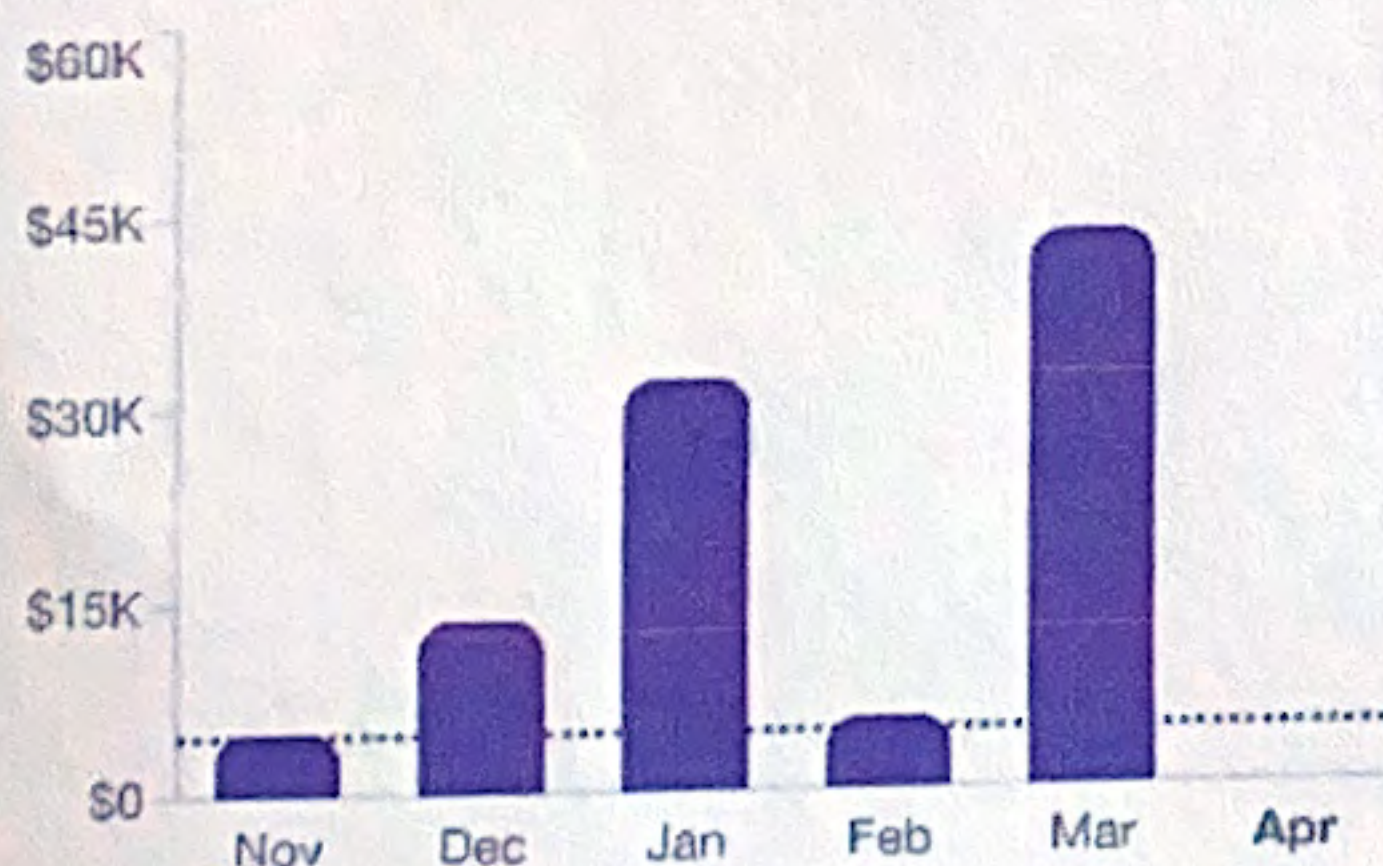

This is close to what your business typically earns by this point in the month.

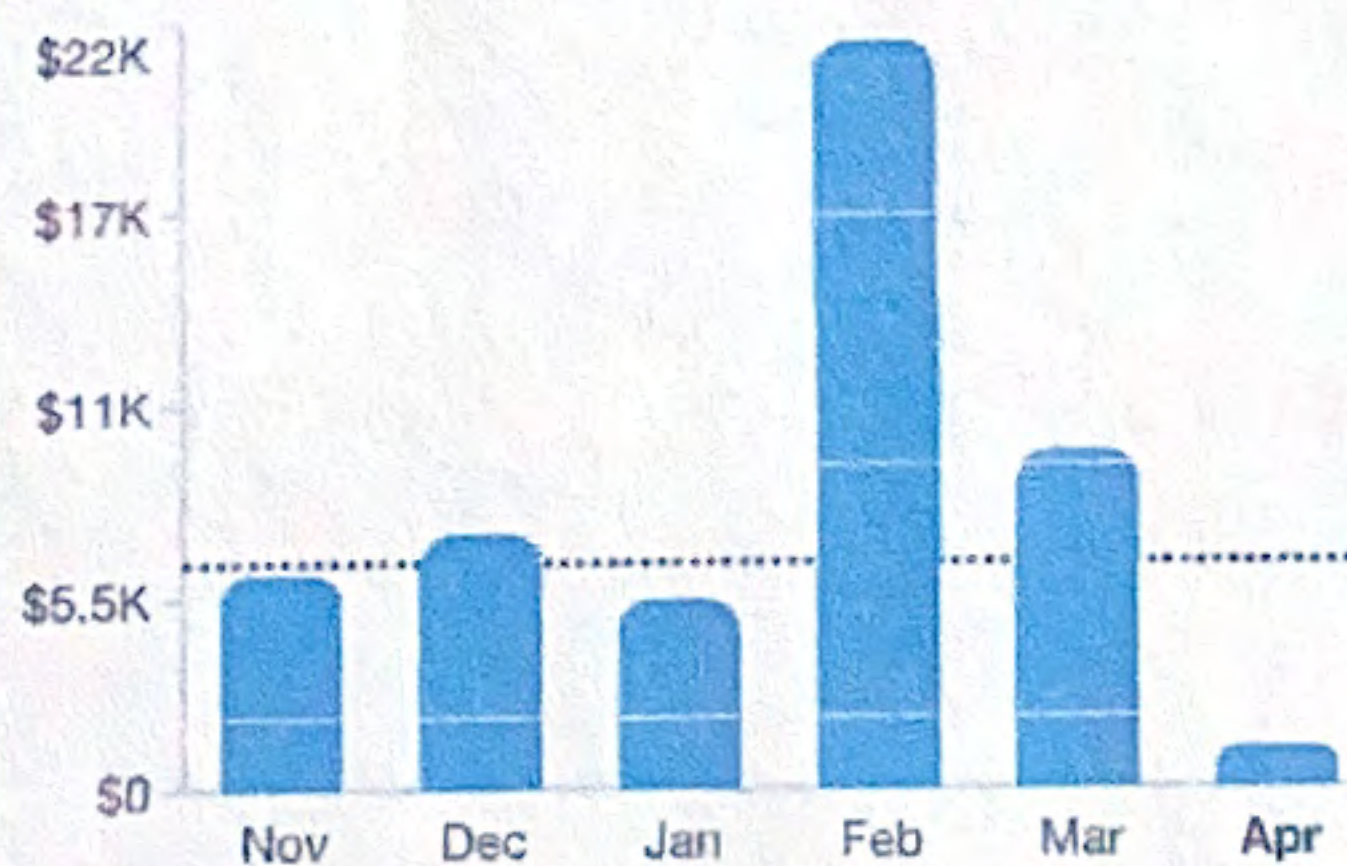
